PERSONAL DATA

By responding to this RFI, the Applicants/Bidders may share Personal Data which may be processed by FIND for the purpose of creating an internal database of antibody producers (The "Purpose"). For the avoidance of doubt, Personal Data shall mean any information that identifies, or is reasonably capable of being identified with, a particular individual, such as but not limited to, names, addresses, telephone numbers, electronic addresses, social security numbers, credit card numbers, medical records and demographic information.

The rights in relation to Personal Data (include but are not limited to the following):

- *Access, correct, withdraw, or delete your Personal Data; however, FIND may need to keep your Personal Data as long as it is necessary to achieve the Purpose;*
- Restrict the types of activities FIND can do with your Personal Data;
- Object to using your Personal Data for specific types of activities; or
- Withdraw your consent to use your Personal Data for the Purpose abovementioned. (However, this withdrawal will only apply to new Personal Data not yet collected or created. Personal Data already collected or created may continue to be used for the Purpose as further detailed herein).
